**Draft Trading in Public Places Bylaw 2024** 

# Southland District Council is now inviting submissions on the draft Trading in Public Places Bylaw 2024.

Southland District Council is reviewing the following documents:

- the Trading in Public Places Bylaw 2013
- the Signs and Objects on Roads and Footpaths Bylaw 2016
- the Alfresco Dining Policy 2015

These documents have been consolidated into the omnibus **draft Trading in Public Places Bylaw 2024** which includes rules regulating and managing trading activities such as mobile trading, alfresco dining, retail displays and signage in public places that are owned or controlled by Council.

The draft bylaw contains some general conditions that aim to prevent nuisance, health and safety issues arising from trading activities in public places. The draft bylaw also has specific sections that provide provisions to regulate:

- the level and intensity of mobile trading activity in public places
- the use of street dining furniture to keep streets clean, safe and not hindering pedestrian flow
- the placement of retail displays and signage on footpaths and berms under the control of Council.

The draft bylaw also contains general information regarding:

- · how to get approval
- · information about enforcement
- · information about penalties

We would appreciate any feedback you have on this draft bylaw.
