



## Draft Use of Unmanned Aerial Vehicle (UAV) Policy 2023

Southland District Council is reviewing its Use of Unmanned Aerial Vehicle (UAV) Policy and is inviting submissions on the draft policy.

In addition to the rules set by the Civil Aviation Authority, Council has the ability to approve or decline use of UAVs over land it owns or administers. While Council's current approach is to enable UAV usage, the draft policy sets out the criteria where written approval might need to be sought in areas assessed as restricted such as over sports fields or swimming pools. While there are currently no areas assessed as prohibited, the draft policy also allows Council to identify any areas where UAV use may be prohibited in all instances.

We recommend before completing this submission form you familiarise yourself with the draft policy and the supporting information, which summarises the policy and any proposed changes. If you make a written submission, you can also request to make an oral submission at a hearing.
